#### 1) **Website:**

- Initial page will include basic information including:

#### 2) **Mailing Lists / Communications**

- Board is concerned that we do not have good/consistent means to capture and communicate to perspective officials. Such as former/inactive members/interested prospect mailing list (separate from Arbiter Member emails).

#### 3) **Meeting Schedule:**

- Coaches Social to be scheduled late October (Dale Hanover working on date)

#### 4) **Post Season Eligibility / Applications / Selection Process:**

- **CIF** – Mark Dexter will continue to make CIF assignments with input from the Board as may be appropriate.
- **Masters** – keep the Masters Applications process as established last year to be considered. Board or Post Season Committee to refine the application requirements/guidelines for consideration. Board will approve final assignments with input from Mark Dexter and/or Post Season Committee as appropriate.

- **State** – keep the Application process as established. Board to refine the application requirements / guidelines for consideration
- SDCWOA should work to clarify and document the criteria and provide guidelines for consideration (who should submit applications). These should be provided/available to all members and reviewed regularly in order to update/refine as appropriate.

What makes Member eligible for CIF, Masters and State consideration and what type of “resume” / experience should a Member have to submit a Masters or State application for consideration.

#### 5) **Mentoring / Evaluation process:**

- Need to work on a process to pair our new(er) officials with experienced ones to mentor them on their officiating and further refine their skills to prepare them for their next level (JV, Light Var, Var, CIF, Masters, State) **-No movement on this**
- Carl Clifford is to follow-up with Dale Hanover regarding a training outline/syllabus for doing training education with our “rookie/newer officials” during their breakout sessions. Sergio Cortez said he would help to facilitate this. **-Dale was still waiting on this to be delivered.**
- John Hernandez and Dick Worsely have decided that they are not available to help with training and/or evaluating this year.**
- J. Davis mentioned the possibility of bringing in other potential evaluators, but the Board did not agree with this idea. The board feels that the head ref at any given tournament has plenty of time to evaluate the remainder of the crew.**
- Lots of invigorated conversation regarding State App’s and who is qualified and who should and/or shouldn’t be part of that decision.**
